## 1. CALL TO ORDER – President Ted Carter called the meeting to order at 1:30 p.m.

## 3. PRESIDENT'S REPORT

## 4. EXECUTIVE DIRECTOR'S REPORT

Dr. Matthew Hastings, Executive Director, NSWERS made a presentation on behalf of himself and the Management Team regarding the Strategic Plan and appraisal over the last 18 months. (See attached PowerPoint.)

**Goal 1 – Establish a Data System.** Dr. Hastings reported that this goal is approximately 31% complete, and facilitated the LB 1160 Report, which you have in draft form today, and is due to the Legislature on December 1. This report offers recommendations to the Legislature to direct state entities to enact new data collections and the sharing of existing data elements. Note that under the Nebraska Department of Education, a student's SSN is listed for record matching purposes. Dr. Hastings reminded the Council that this report is in draft form and realizes the significance of asking for a student's SSN at the K-12 level, but by having that information there is a much better possibility of tracking that student through data collected by the Department of Labor as well as the Department of Revenue. Dr. Hastings indicated that some data is not even being shared as the data does not show up from any entity if self-employed, not employed and in some instances, data may be exempt, like the railroad companies, as some information is exempt from their payroll.

The proposed draft of the LB 1160 Report also offers funding recommendations that an annual appropriation be directed to any of the nine NSWERS partner organizations specifically earmarked to support the NSWERS entity. Dr. Hastings reminded the Executive Council that the LB 1160 report is in draft form, and he will have conversations with each of the Executive Council members and the Management Team before putting the Report into final form and submitting by the December 1 due date.

Dr. Hastings reported that the updated comprehensive Strategic Communications Plan ensures a consistent and traceable flow of information that NSWERS will use to communicate with board and committee members, partners, affiliates, and relevant constituents, including the Legislature.

Dr. Hastings conveyed that, with input from the Executive Council and Management Committee, the Executive Council business meetings have been scheduled through April 2023. Also, Dr. Hastings reported that the Nebraska State Auditor of Public Accounts has approved the waiver request.

Dr. Hastings talked about the projected outcomes from the Information Agenda summary for Education and the Workforce and the process in which to reach same, which correspond to the strategic plan. The Information Agenda will help identify research to be done and assist in decision making.

Dr. Hastings reminded the Council of the robust data security process in place and as indicated earlier this year, additional Cyber Liability Insurance is needed as the NSWERS warehouse is further developed and the NSWERS data enterprise is established. The request for more cyber liability insurance is on today's agenda. NSWERS, in cooperation with NU ITS, has classified all NSWERS data as high-risk data and as such appropriate security controls are in place.

Dr. Hastings introduced new staff that have joined NSWERS and who are here today. Katie Bieber, Communications Manager; Alex Brodersen, Assistant Director, Research and Evaluation; Sam Kapoor, Assistant Director, Database/ETL Development; and, David Hefley, Application Developer. Dr. Hastings reminded Executive Council that the security of the data being collected is a high priority for NSWERS and NSWERS requires all employees to undergo intensive data security training. Core services and loaned employee agreement drafts are currently under review and on today's agenda.

Dr. Hastings provided drafts of the file specifications for defining NSWERS data collection: K12 File Specifications; Postsecondary Specifications and Workforce Specifications. Each of these file specifications describe the data elements collected by NSWERS and provides valid values and data validation rules that can be performed prior to data submission.

**Goal 2** – **Evaluate Efficacy.** Dr. Hastings reported that this goal is approximately 31% complete; with the Information Agenda approximately 81% complete. An operational Information Agenda will allow NSWERS to manage procedures and progress to measure the efficacy of the system by adopting solutions for timeliness, relevance and accuracy allowing NSWERS to continue to push to support decision-making.

Dr. Hastings provided information sheets that illustrate a NSWERS Decision Dashboard as well as samples of data products that, with accurate dissemination, will lead to making informed decisions using data analysis and prediction operations.

Commissioner Blomstedt thanked Dr. Hastings for the update and inquired if the NSWERS products are or will be web based and as partners/entities move more to the right of the process (predict, forecast, simulate) how secure is the information? Dr. Hastings indicated that he is envisioning that this would be a web based portal for NSWERS and will be secure for NSWERS partners/entities and will have standard verification in place for each entity before downloading any data to that partner/entity.

Dr. Hastings did report that when looking at the POC, half of the students in K-12 cohort are not identified going forward to higher education. There are no matches with NDOL, that whole segment is gone, and the quickest and easiest solution would be to get student SSN from K-12 schools. The identity resolution process is proving to be a challenge and working around the SSN would take a lot of time, at least another 18 months, and put everything "on hold" and would include asking NDOL to have more information so more data could be matched. It is imperative to have correct data collected in order to have correct data analyzed to make informed decisions.

Dr. Blomstedt suggested that perhaps a conversation with the Legislature expanding on the significance of student SSN should be included when presenting the LB 1160 Report.

President Paul Illich asked if the partners/entities can have access to the raw data so they can create their own model from the data. Dr. Hastings stated that there will be a mechanism in place that that can be done. Data can be used as a product and as a service.

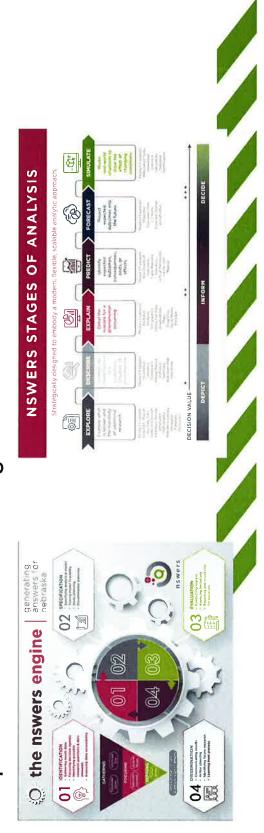
