### 5. SPECIAL PRESENTATIONS AND DISCUSSIONS

**5.1** Access College Early (ACE) Scholarship Program Evaluation (Dr. Mike Baumgartner)

Dr. Mike Baumgartner from the Nebraska Coordinating Commission for Postsecondary Education presented on the ACE (Access College Early) scholarship program, which provides tuition assistance for low-income students taking dual credit courses. The ACE program currently serves over 2,000 students per year, but the Commission has not been able to track long-term outcomes like persistence, retention, graduation, and workforce placement for these students. The Commission would like to partner with NSWERS to conduct an evaluation of the ACE program, comparing outcomes for ACE scholarship recipients to similar non-recipients. This would allow the Commission to better understand the program's efficacy.

The proposed evaluation would use 2017-18 as the baseline year, as that was a time when the program was fully utilized before changes to community college dual credit funding. The evaluation would use propensity score matching and regression discontinuity analysis to compare ACE recipients to similar non-recipients across key outcomes.

The Council expressed strong support for this proposed evaluation, noting it aligns well with NSWERS' mission and could provide valuable insights to inform policy decisions around the ACE program. NSWERS staff confirmed the data

management policies allow for such evaluations to be conducted if approved by the Council.

### 6. EXECUTIVE DIRECTOR'S REPORT

Dr. Hastings, Executive Director, NSWERS made a brief presentation on behalf of himself and the Management Team. (See attached PowerPoint.)

Dr. Hastings provided an update on the data submission and certification process, noting that NSWERS now has about 12 years of validated and certified data in the system. He highlighted that this represents about 26,000 separate analyses that can be conducted across the 8 outcome areas within insights+.

Hastings then discussed the technical enhancements being made to the insights+ platform, including:

- The ability for users to create custom populations to analyze, rather than just using the statewide populations
- A new query builder tool that allows users to further filter and transform the data
- A data request wizard to streamline the process of requesting custom data extracts

Dr. Hastings explained that these enhancements are intended to significantly increase the utility and usability of the insights+ platform for NSWERS partners.

Regarding the public-facing insights website, Hastings indicated it is nearing launch and asked the Council for input on how they would like to coordinate a public rollout, potentially through a joint press event.

Dr. Hastings provided an update on the upcoming meetings to discuss potentially adding financial aid data elements, like Pell eligibility and EFC, to the NSWERS data specifications.

He also gave a brief update on the status of the NSWERS legislative bill, noting they are working with Senator Hughes on drafting the bill and exploring options to have the appropriation included in the Governor's budget.

Finally, Dr. Hastings reviewed NSWERS' progress on its strategic plan objectives, noting they are now at 92% completion overall.
